Intended Peaceful Demonstration by NamPost Employees

NamPost has taken note of a letter by the Namibia Public Workers Union (NAPWU) circulated on social media in respect of an intended peaceful demonstration by its employees, excluding its management.

NamPost had a series of meetings with NAPWU to address the issue of the annual wage demands for 2021. However, the two parties failed to reach consensus with NAPWU wanting an 11.02% increase and NamPost offering a 1.5% increase. Subsequently, NAPWU lodged a dispute with the Labour Commissioner. Whilst this process is ongoing, the employees opted for a demonstration.

The countrywide demonstration is planned to take place on 12 October 2021 between 13:00 - 14:00 at NamPost offices with an intention to hand over a staff petition to the Chairperson of the board of Directors of NamPost.

It is noteworthy that whilst the COVID-19 pandemic was at its height in the country and impacting on all economic spheres, no salary cuts were effected for NamPost employees, and no employees were retrenched. Moreover, NamPost awarded an overall salary increase to employees, excluding management, of 2% the previous financial year.

We would like to inform our customers that no service interruptions are expected and that NamPost remains open to dialogue with NAPWU to reach a mutually beneficial outcome to the ongoing wage negotiations.
